1	The Import container details for the movement needs to be provided 72 Hrs before arrival/discharge of the container in the Terminal.
2	The assessed Bill of Entry to be provided 48 Hrs prior Vessel arrival.
3	Ruby Global Warehousing LLP (RGWLLP) SEZ shall not be liable for port ground rent if import container movement documents are not submitted on time
4	Movement of import empty containers shall be initiated only upon receipt of a valid Delivery Order. The Delivery order must be submitted at least 48 hours prior to expiry of validity date
5	Storage charges will commence from container gate in at RGWLLP FTWZ.
6	All CHA Activities are in the scope of the customer.
7	Vehicle detention charges shall be payable by the client in cases of vehicle detention, documentation errors, delays, or if the vehicle is held up at the client's end for any reason attributable to the client.
8	Any Value Addition Services or special equipment that may be rendered to the Customer would be charged additionally as per the scope of work on case-to-case basis
9	Idling labor charges will be levied if the stuffing/de-stuffing plan is cancelled/postponed by the client.

10	Customer will be responsible to obtain any / all statutory Approvals / Permissions that may be required to Import / Export / handle the cargo in FTWZ or DTA.
11	The customer shall cover the Insurance and secure the Cargo & Container against all risks appropriately.
12	The customer shall inform about any discrepancy in the raised invoice to RGWLLP within 5 days from the receipt of Invoice ,or else such Invoice shall be considered as true and correct and payable.
13	The customer's security deposit is adjustable with the outstanding payment payable at the time of contract termination.
14	Customer's Security deposit - USD 2500 or Equivalent INR
15	All payments are to be made in USD
16	Statutory charges (GST) will be levied as applicable.
17	All Shipping line, Port, and Terminal charges, such as delivery charges, Terminal Handling Charges (THC), shifting charges, documentation, storage,detention and/or any other charges levied by the respective Shipping line, Port, orTerminal authority are to be borne directly by the customer. In cases where such charges are billed to RGWLLP, the same will be invoiced to the customer . If the customer opts for RGWLLP to handle all such payments on their behalf, a management fee of 10% will be applicable. Bills raised on the customer in this regards will be subject to applicable taxes as per prevailing guidelines.
18	All charges and/or payment shall be exclusive of all Bank charges, GST and other taxes. Any commission fees or
